

Public Behavior, Preservation of Property & Resources

1. Good campers are always considerate of others. The noise level must be controlled at all times so as not to disturb other campers. We especially ask that a quiet time be observed from 11:00 p.m. to 6:00 a.m. EDT.
2. For all campers' safety, please do not build fires outside of stoves, grills, fireplaces, or fire rings provided for such purpose.
3. Pets are not allowed at camping sites unless they are on leashes at all times.
4. To protect the environment of the park, please do not destroy, deface, or remove any natural feature or plant or harass wild animals or birds.
5. Please help maintain the appearance of the park by not destroying, defacing, or removing any building, sign, equipment, marker, or other park property.
6. For the safety of all campers, you are not permitted to discharge firearms, firecrackers, or any fireworks in the park or campgrounds.

Note: *Discharging firearms is not allowed within 450 feet of the park, campgrounds, or campground road. No target shooting is permitted in the park at any time.*
7. Moving park picnic tables is prohibited. One picnic table is permitted per site.

Storage

1. It is not permitted to store or leave a boat or other property on Bond Falls Flowage. Campers may moor their boats only during their stay.

Solicitation Policy

The following are not allowed on the hydroelectric lands without prior written approval from UPPCO: peddling or solicitation of any kind; distribution or posting of handbills, signs, or any other items; marking of any kind on trees or rocks; and commercial activity of any kind.

Violation of any of these regulations will result in loss of the privilege to use Upper Peninsula Power Company lands at Bond Falls Flowage and may result in charges or other legal action being brought against the violator by the company.

The Park Manager, Michigan State Police, Ontonagon County Sheriff's Department, Michigan Department of Natural Resources, and authorized employees of Upper Peninsula Power Company are authorized to enforce these regulations.

Regulations Governing the Recreational Use of UPPCO Lands at Bond Falls Flowage

The following rules and regulations have been established by the Upper Peninsula Power Company to increase the overall enjoyment of recreation on company lands at Bond Falls Flowage. They are common sense rules meant to control actions that cause damage to natural resources and facilities, as well as actions that cause unreasonable disturbance for other visitors. Observance of these rules will make your visit and the visits of others more pleasant and enjoyable.

The following regulations apply to all persons entering, using, or visiting Upper Peninsula Power Company lands at Bond Falls Flowage.

Camping permits will be posted at entrance roads to each site. Entrance into individual campsites when they are occupied by others is prohibited.

Occupancy of Recreation Areas at Bond Falls Flowage

1. Camping will be permitted only in established campsites on a first-come first-served basis. A site will only be assigned when a permit is issued. Requests for specific sites will be honored if the sites are available.

2. The senior responsible person of the party (18 years or older) must register for the camp and occupy it. The permit will be revoked for any camp that is continuously vacant for longer than 24 hours.
3. Not more than one single family nor more than four unrelated persons shall camp on one campsite. Only one main shelter, plus a two person "pup" tent for children, is permitted at each campsite. No camp shall occupy more than one site.
4. Not more than two vehicles will be permitted per camp. Each vehicle must be registered on the camp permit and be identified with an issued sticker, which is to be placed on the back of the rear view mirror. The park office should be advised of any additional vehicles, which must be parked in one of the Visitor Parking Areas.
5. From June 1 through September 15, no person may camp for more than 14 nights per season.
6. If sites are available, an extension to the permit may be obtained prior to 8:30 a.m. EDT of the day the permit expires. A campsite could be assigned to another camper if the permit is not extended by 8:30 a.m. (provided it does not exceed 14 days per season). Therefore, we recommend the extension be obtained the prior day.
7. Visitors must leave the campground by 10:00 p.m. EDT.
8. Campers may not leave a camping unit unoccupied overnight or leave camping equipment unattended for more than 24 hours without written permission from the park manager.

9. From June 1 through September 15, no camping facilities (trailer, motor home, boat, etc.) shall be on-site for more than 14 nights per season.
10. Island campers are subject to all standard rules, plus the following:

Bury human waste, and take all garbage to the mainland and place it in a proper receptacle. Island campers will be instructed where to park.

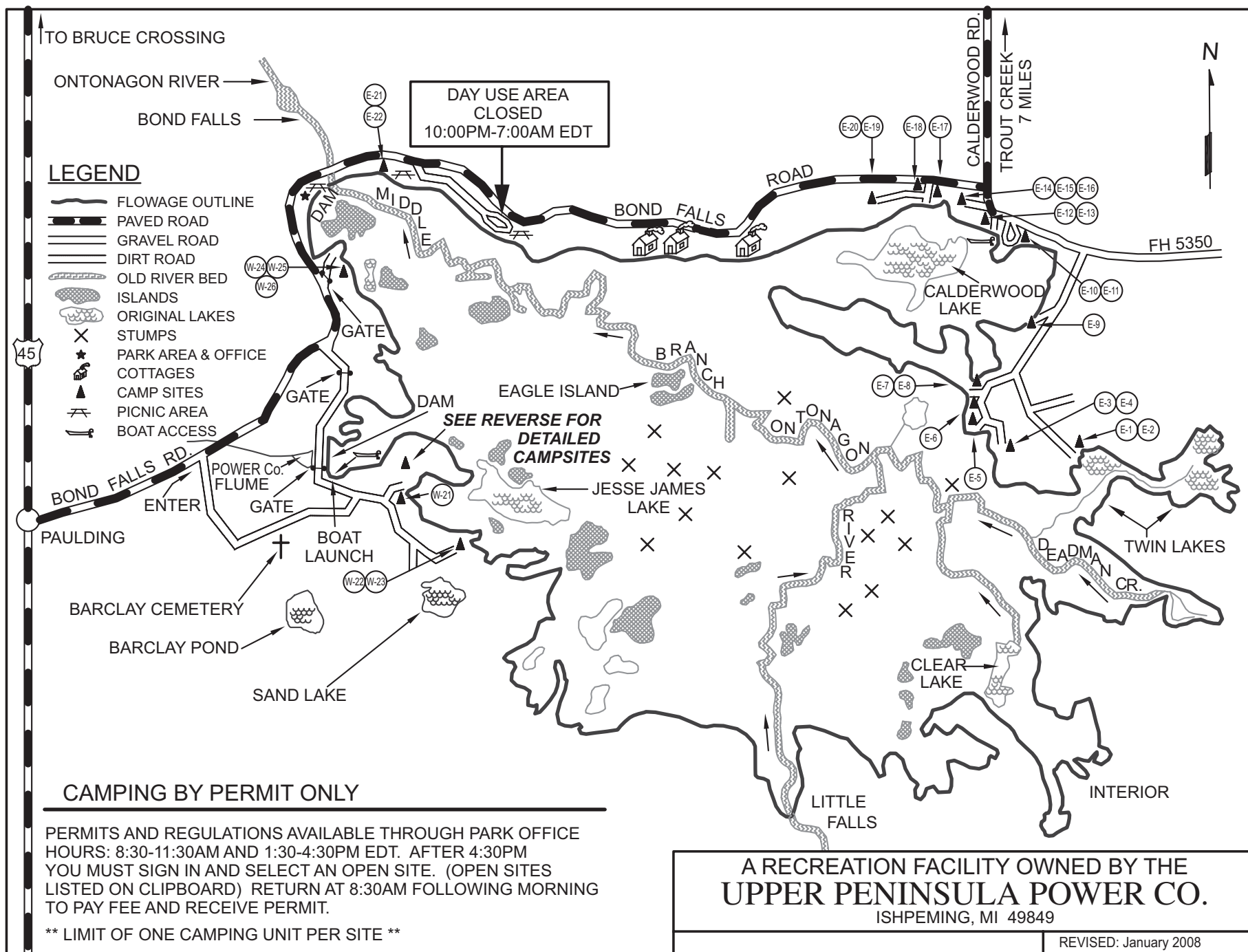
Sanitation

1. Please dispose of all garbage by removing it from the site or area or disposing of it at places provided for such disposition.
2. Draining or dumping refuse or waste from any trailer or other vehicle is not permitted.
3. The park's garbage containers are not to be used for dumping household or commercial garbage or trash brought from off the property.

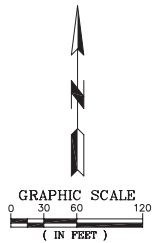
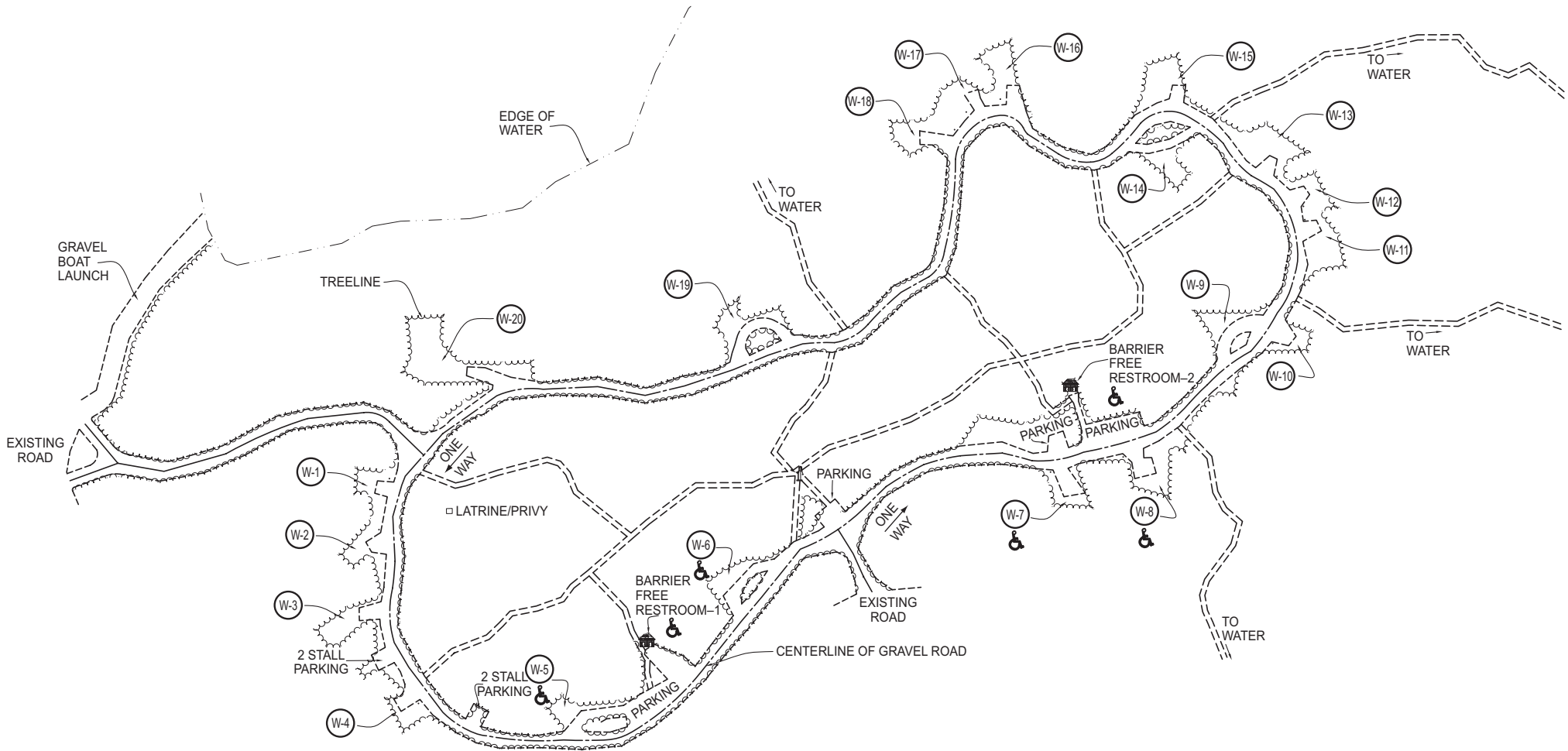
Vehicles, etc.

1. Please observe the 15-mph speed limit throughout the campground for the safety of all campers.
2. Off-road vehicles are not permitted in the park or campgrounds.
3. Horseback riding is not permitted in the park or campgrounds.
