- Determine Eligibility.** Review the eligibility requirements and terms and conditions throughout the application to verify that you are eligible for rebates on energy-saving products.
- Complete the Application and Attach Invoices.** Submit completed pages 1–3 and supporting documentation within 60 days of installation. Please retain a copy of all invoices and your completed application for your records.

### Eligibility:

- Applicant must be a residential Upper Peninsula Power Company delivery service customer at the time of equipment installation.
- Equipment must be purchased and installed between January 1, 2021 and November 30, 2021.
- Application must be submitted within 60 days from purchase date or by November 30, 2021, whichever comes first.
- Equipment must meet the stated requirements to qualify for a rebate.
- Rebate cannot exceed the cost of the energy efficiency improvement.

### What You Will Need:

- A copy of your sales receipt/invoice indicating equipment type, manufacturer, model number, purchase/installation date and price
- Your utility account number and a copy of most recent bill
- Installing contractor information, if applicable
- Proof of ENERGY STAR certification

These Standard Terms and Conditions for participating Customers and the and the 2021 Rebate Program Application Customer Participation Agreement (collectively, the "Agreement") for the Upper Peninsula Power Company ("Sponsor") are made and entered into by and between CLEAResult Consulting Inc., a Texas corporation and/or an affiliate thereof ("CLEAResult"), and Customer for the purpose of evaluating and installing energy efficient measures ("EEM") under the 2021 Rebate Program ("Program") funded by Sponsor. CLEAResult and Customer may be referred to in this Agreement individually as a "Party" and collectively as the "Parties." The Parties acknowledge and agree that the state regulatory governing body (the "MPSC") and, Sponsor and Contractor are third party beneficiaries of this Agreement. In consideration of the mutual covenants and agreements set forth below, the adequacy and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

**APPLICATION:** This application and any required additional documentation, including the invoice, must be filled out completely, truthfully and accurately. Customers are advised to retain a copy of this application and any accompanying documentation submitted to Efficiency United\* and their contractors under this program. Sponsor and their contractors will not be responsible for lost documentation pertaining to this application request. Details of this program, including rebate levels, are subject to change or cancellation without prior notice. This application with required documentation must be received within 60 days of the purchase/installation completion. **ACCESS AND PARTICIPATION:** Customer agrees to support CLEAResult and Contractor and assign a representative to facilitate services provided under this Agreement. Customer acknowledges its intent to install EEM using Program incentives. Customer agrees to allow CLEAResult and Contractor to access its facilities, energy use and cost information for the purposes of implementing this Agreement. If Customer is a tenant, Customer represents that by signing this document they have obtained the property owner's permission to install EEM under this Agreement. Customer agrees not to use the name or identifying characteristics of Sponsor or its contractors for any advertising, sales promotion, or other publicity of any kind. Customer also confirms that it has not and will not receive rebates, incentives or services for any measures installed under this Program from another program funded by Sponsor. The Program may be modified or terminated without prior notice and this Agreement is subject to modifications by Sponsor.

**LIMITED FUNDS:** Funds for rebates are limited and available on a first-come, first-served basis. Rebate amounts are valid while funds last. Sponsor and their contractors reserve the right to not pay this CLEAResult may not pay the rebate if funds are not available at the time of application approval, or if the form and all required additional information are not filled out completely and accurately.

**ELIGIBILITY:** This offer is valid for residential customers of Sponsor installing EEM in Sponsor territory only applying through an Sponsor residential program only. Customers applying for a rebate must receive service from a participating Sponsor utility. This offer is not valid for new construction homes or commercial properties. Equipment must be installed in a participating Sponsor service territory. Each customer is eligible to receive rebates up to the stated maximums, irrespective of which Sponsor program(s) participation occurs in. liability that may be imposed on the customer as a result of the payment of rebates. Please contact your tax advisor for more information.

**FACSIMILE/SCANNED:** Facsimile transmission of any signed original document, and the retransmission of any signed facsimile transmission, shall be the same as delivery of the original signed document. Scanned original documents transmitted to Sponsor and their contractors as an attachment via electronic mail shall be the same as delivery of the original signed document. At the request of Efficiency United, customer shall confirm documents with a facsimile-transmitted signature or a scanned signature by providing the original document. Such parties will treat such Information as confidential and the Information in the Reports shall only be in the aggregate.

**INCENTIVE PAYMENT.** Customer acknowledges that incentives will be paid by Sponsor only if: (a) Customer(s) and installed measures(s) or services meet the Program eligibility requirements and the requirements outlined by the Program; (b) measures are installed in eligible project sites; and (c) measures are installed at a project site that has not received incentives from any other of Sponsor's energy efficiency programs for the same measure(s). Customer understands that Sponsor, in its sole discretion, may withhold incentive payments committed to the Customer if a project site is proven ineligible or a project otherwise does not complete with the requirements set forth by the Program. Customer acknowledges that the incentive amount may not exceed the cost of the EEM. Funds for incentives are limited and available on a first-come, first-served basis. Incentive amounts are valid while funds last. The Program reserves the right to not pay this rebate if funds are not available at the time of the application approval, or if this application and all required additional information are not filled out completely and accurately.

**CONFIDENTIALITY.** CLEAResult shall keep Customer information confidential. Only Contractor, Sponsor and the MPSC shall be granted access to Customer data as needed or required. CLEAResult will not use the name or identifying characteristics of Customer in advertising sales promotion or other publicity without Customer's written approval.

**NO WARRANTY.** CLEAResult, Sponsor and the MPSC make no representations or warranties, and assume no liability with respect to quality, safety, performance, or other aspect of any EEM installed pursuant to this agreement and expressly disclaim any such representation, warranty, or liability, including but not limited to the implied warranties of merchantability, fitness for a particular purpose, and noninfringement. Neither the MPSC, Sponsor, nor CLEAResult shall be responsible for costs of corrections of conditions already existing in the facilities inspected which fail to comply with applicable laws and regulations.

**INDEMNIFICATION; LIMIT ON LIABILITY.** Customer agrees to indemnify the MPSC, Sponsor and CLEAResult against all loss, damages, costs, and liability arising from any claims related to any products installed or services performed during the installation or maintenance of EEM. Neither the MPSC, Sponsor, CLEAResult, nor customers shall be liable to each other for an incidental, special, indirect or consequential damages related to this agreement.

**MISCELLANEOUS.** This Agreement shall be governed by and construed under the laws of the State of Michigan without regard to conflict of law rules. The parties agree that all actions, disputes, claims and controversies arising out of or relating to this Agreement or the work performed hereunder will be subject to binding arbitration administered in the county where the Customer is located by the American Arbitration Association under its Commercial Arbitration Rules and judgment on the award may be entered in any court having jurisdiction. Customer shall not assign, delegate or subcontract this Agreement or its duties thereunder, in whole or in part, voluntarily or involuntarily (including a transfer to a receiver or bankruptcy estate) without the prior written permission of CLEAResult. CLEAResult may assign its rights and delegate its duties under this Agreement to any third party at any time without Customer's consent.
